

# Kaipara Flats School (1324)

## Enrolment Scheme

(February 2020)

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

### Home Zone

**All students who live within the home zone described below and shown on the attached map shall be entitled to enrol at the school.**

*Starting at the intersection of Woodcocks Road and Old Woodcocks Road travel north east along Woodcocks Road (576-1180, 583 – 1157 included, West Coast Road 1414-1486, 1417-1495 included, Maththew Road included) to the intersection of Woodcocks Road and Old Kaipara Road. Travel along Old Kaipara Road (8 and above included) onto Streamlands Swamp Road (119 and below included) then north towards Kaipara Flats Road. From Kaipara Flats Road (377, 380 and above included) turn right and then left onto Smyth Road (4, 5 and above included, Kraack Road included) Travel along Smyth Road and then onto Pegasus Road from which travel west across country to Tauhoa Road. Travel South along Tauhoa Road (403, 408 and above included and J Mason Road included) towards the intersection at Kaipara Hills Road (301, 483 and above included). From the intersection of Tauhoa Road and Kaipara Hills Road travel onto Kaipara Flats Road then south down Old Woodcocks Road back to the starting point*

All residential addresses on included sides of boundary roads and all no exit roads off included sides of boundary roads are included in the zone unless otherwise stated.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

### Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

### Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received. Applications for out of zone children will likely close in October.

Applications for enrolment will be processed in the following order of priority:

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

**Applicants seeking second or third priority status may be required to give proof of a sibling relationship.**
